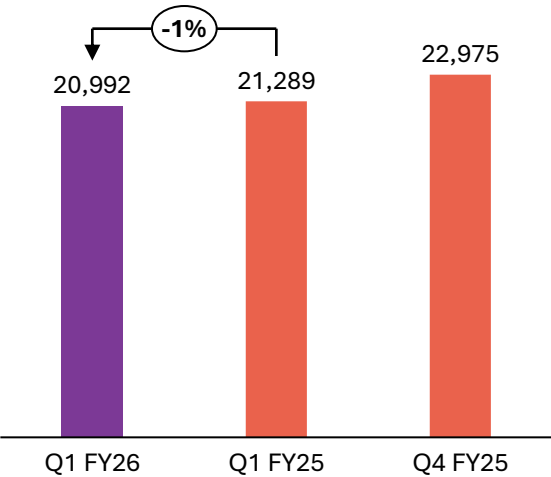

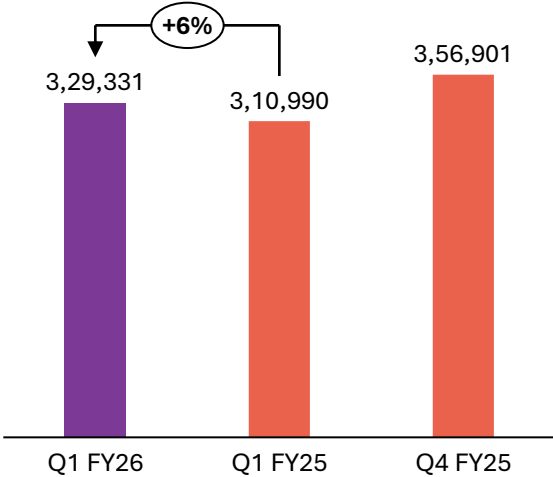

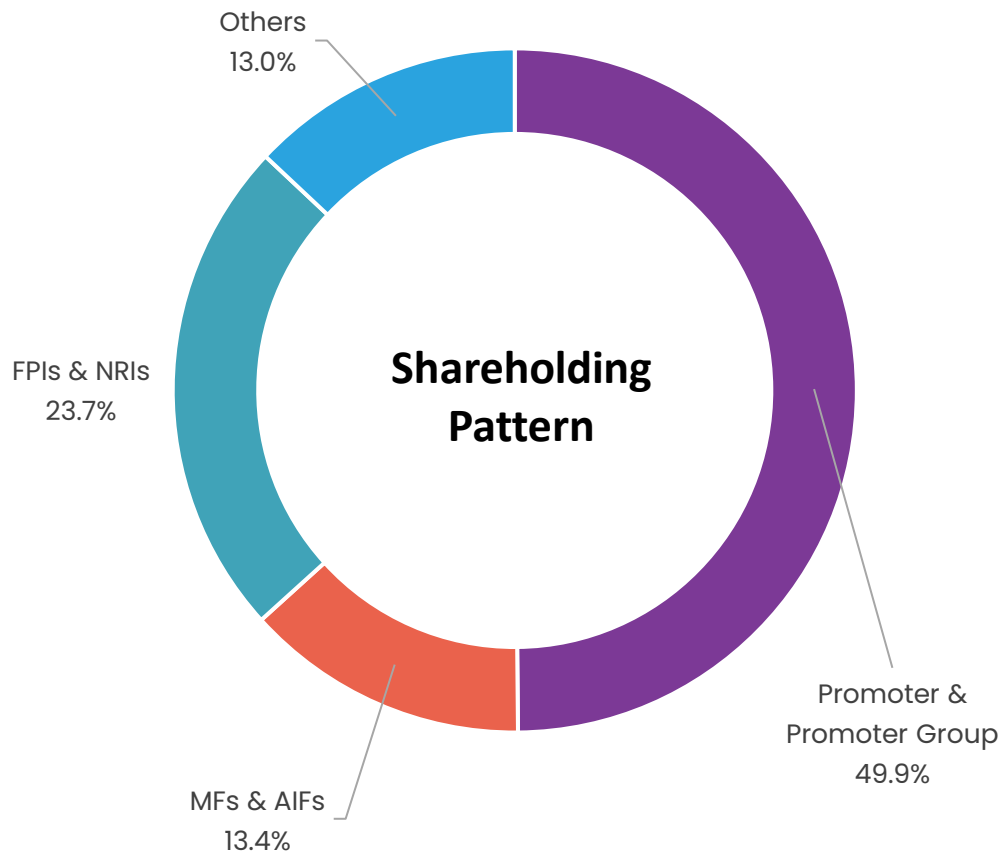

Appendix

Winter feels like magic again : Cured from Sickle beta thalassemia by Bone marrow transplantation

- A 15-year-old adolescent diagnosed with Sickle Beta Thalassemia in infancy
- The child received over 30 blood transfusions until now. The condition led to repeated painful sickle cell crises triggered by dehydration, infections, and cold weather, and eventually resulted in avascular necrosis of the hip joint — a serious complication caused by restricted blood supply.
- In a significant step toward cure, the individual underwent a bone marrow transplant at Rainbow Children's Hospital, Marathahalli, Bengaluru, with a sibling serving as the donor.
- Despite complex challenges post-transplant — including Passenger Lymphocyte Syndrome, a rare immune complication due to differing blood groups — the situation was managed with expertise and precision by the hospital's Bone Marrow Transplant team.
- **The successful outcome highlights Rainbow's capabilities in delivering advanced, life-changing care for rare pediatric hematological disorders.**



Congenital Absence of Sternum : A Rare and a challenging Entity

- A 5-day-old newborn was brought to the Rainbow Children's Heart Institute, Hyderabad with a **rare anterior chest wall deformity** where visible and paradoxical chest movements were observed, despite normal heart structure on echocardiography
- The pediatric surgical team performed a **reconstructive procedure using bilateral pectoralis major myocutaneous flaps** — a technique that utilizes the chest muscles to restore structural integrity.
- Post-operatively, the child experienced temporary diaphragmatic weakness, which resolved over time.
- The baby was discharged in a stable condition, breathing comfortably without support and feeding well.
- This case underscores Rainbow's multidisciplinary expertise in managing complex neonatal thoracic conditions with excellent outcomes.



Mother's Hope Rekindled : From multiple failed Conception to the gift of Twins

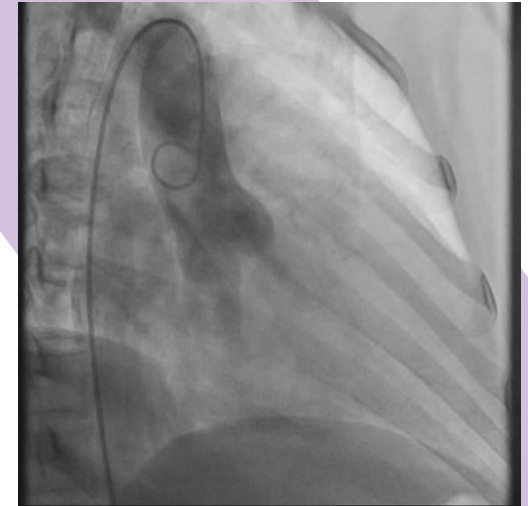
- A couple in their late 30s had been trying to conceive for over two years. Despite having regular cycles and two successful IUIs, both pregnancies sadly ended in miscarriage.
- After multiple failed IVF attempts outside and being advised to consider donor eggs, the couple arrived at BirthRight by Rainbow with renewed hope.
- The mother was diagnosed with poor ovarian reserve, a condition indicating a lower number of eggs than typical for her age.
- The fertility team at BirthRight crafted a customized IVF protocol, specifically tailored to her clinical profile.
- With continuous guidance, emotional support, and medical expertise, the couple's journey culminated in joy — they were blessed with healthy twins conceived using the mother's own eggs within a year.
- **This case exemplifies BirthRight's strength in providing empathetic, individualized fertility solutions that deliver both scientific success and emotional fulfillment.**

Innovative Heart Device (US-Patented KONAR-MF) – Multifunctional Occluder Broadens its reach across the age spectrum

- Dr. Nageswara Rao Koneti, senior paediatric cardiologist at Rainbow Children's Heart Institute, has been granted a U.S. patent for his innovative heart device – the KONAR-MF Occluder.
- A 22-year-old individual was admitted in heart failure and diagnosed with a ruptured sinus of Valsalva — a rare and serious condition where a rupture near the aortic root creates an abnormal connection between the aorta and the heart.
- In a minimally invasive procedure, the KONAR-MF Occluder was successfully implanted in the cardiac catheterization lab, effectively closing the defect.
- The patient showed significant improvement and was discharged within days, highlighting both the clinical impact of the innovation and Rainbow's leadership in advanced, device-based cardiac care.

When Virus and bacteria collide : The clinical Conundrum of Neonatal Dengue

- A 2.6 kg late preterm baby was born to a first-time mother at Rainbow Children's Hospital, Anna Nagar, Chennai, shortly after the mother was diagnosed with dengue infection.
- By the second day of life, the newborn developed **fever, skin rashes, breathing difficulty, and signs of poor blood circulation** — symptoms linked to neonatal dengue with systemic complications.
- The medical team initiated non-invasive respiratory support (CPAP) and started cardiovascular stabilizing medications.
- The baby's clinical course was further complicated by a bacterial brain infection, likely due to severe dengue-related gut barrier disruption, necessitating the placement of a ventriculoperitoneal (VP) shunt to drain excess fluid from the brain.
