Pursuant to Regulation 30 of the SEBI Listing Regulations, we wish to inform that, the Business Strategy & Investment Committee ("**Committee**") of the Company in their meeting held Today i.e., June 28, 2025 inter alia considered and approved the execution of Share Subscription Agreement and Shareholders' Agreement for acquisition of 76% of fully diluted equity share capital and 100% of Non-Convertible Redeemable Preference shares ('NCRPS') of M/s. Prashanthi Medicare Private Limited ("**Prashanthi Hospital**") which operates 100 beds hospital at Warangal.

Hyderabad, June 28, 2025: Rainbow Children's Medicare Limited (RCML), India's leading pediatric multi-specialty and perinatal care hospital chain, is pleased to announce the signing of a definitive agreement to acquire a majority stake in M/s Prashanthi Medicare Private Limited ("**Prashanthi Hospital**"), at Warangal - the second-largest district and a prominent business hub of Telangana.

Established in 2015 by **Dr. Prasanthi Macha**, **Prashanthi Hospital** is a 100-bed NABH-accredited facility with a strong reputation for delivering high-quality care across obstetrics, gynecology, neonatology, pediatrics, and minimally invasive surgery. Recognized for its clinical excellence, patient-centric approach and strong regional brand equity, the hospital has become a preferred healthcare destination for women and children in Warangal region.

This strategic acquisition underscores RCML's continued expansion in Telangana and further strengthens its presence in southern India. It also reflects the **Company's growth plan to expand into tier-II cities where specialized healthcare services remain underserved**. The addition of Prashanthi Hospital increases RCML's capacity by 100 beds, taking its total network size to 2,035 beds across 20 hospitals in 7 cities.

The transaction values Prashanthi Hospital at an enterprise valuation of **~INR 32.60 crore** (subject to working capital adjustment), **representing ~ 9 times the estimated FY25 adjusted EBITDA** and is fully funded through RCML's existing cash reserves and internal accruals. RCML will acquire a controlling stake of 76% in fully diluted equity capital & 100% stake of Non-convertible Redeemable Preference Shares (NCRPS), while Dr. Prasanthi Macha along with associates will retain a 24% minority interest.

Following the acquisition, the regional hub facility will be rebranded as '**Rainbow Children's Hospital**' for pediatric care and '**Prashanthi with Birthright**' for women's care. The hospital will be seamlessly integrated into RCML's hub-and-spoke network ensuring clinical alignment and streamlined referral network to the Hyderabad hub for advanced tertiary and quaternary care.

Dr. Ramesh Kancharla, Chairman & Managing Director, Rainbow Children's Medicare Limited, said: "We are delighted to welcome Prashanthi Hospital into the Rainbow's network. This partnership enables us to deepen our roots in Telangana and bring high-end pediatric, neonatal, and maternal care to families in Warangal region through our proven hub-and-spoke model, while strengthening our capabilities in multi-specialty pediatric care."

Dr. Prasanthi Macha, Director, Prashanthi Hospital, added: "We are excited to partner with Rainbow, a national leader in pediatrics and women healthcare. Partnering with Rainbow helps us leverage their strong leadership, clinical expertise, and extensive network to provide even higher standards of pediatric and maternal care to our community."

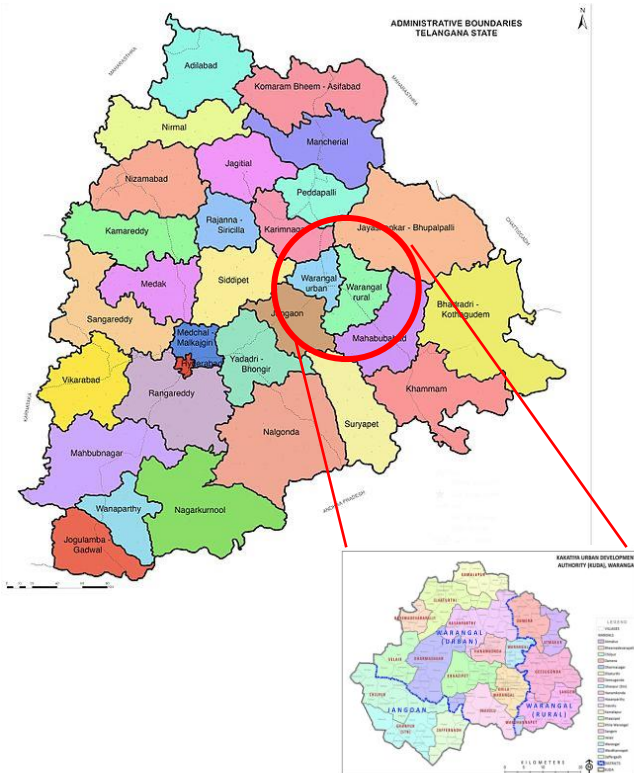

Transaction Details

- The existing proprietorship business has been recently transferred to a newly incorporated entity i.e. M/s Prashanthi Medicare Private Limited, through a Business Transfer Agreement. All requisite medical licenses are being transitioned or obtained in the name of the new company.
- Through the Shareholders' Agreement (SHA), Rainbow will acquire a controlling stake of 76% in fully diluted equity capital and 100% stake in Non-convertible Redeemable Preference Share capital of the company. As per the agreement, Rainbow will have a call option to acquire the remaining shares after six years, while the existing shareholders hold a put option exercisable after five years.
- Hospital will be Re-Branded as under :
 - ✓ "Rainbow Children's Hospital" (Pediatrics Care)
 - ✓ "Prashanthi with Birthright" by Rainbow Hospitals (Women Care)
- Rainbow will invest ~Rs. 24.85 Cr. through Equity (fresh subscription of shares) to acquire 76% stake in fully diluted equity capital
- Rainbow will further invest ~Rs. 7.75 Cr. through Non-Convertible Redeemable Preference Shares (NCRPS) to support Balance sheet
- Whole transaction will be funded from existing cash reserves and Internal Accrual
