Nature and details of the action(s) taken, initiated or orders(s) passed	The Department has imposed a penalty of Rs. 50,000/- along with temporary suspension of the TN Clinical Establishment Certificate of the hospital unit situated at Sholinganallur, Chennai, for a period of 10 days. Further effective from 24.10.2024, all new treatments except those related to continuing pregnant women has to be suspended at the said unit for the next 10 days and all in-patients are required to be relocated to other facilities within 7 days.

This resulted in violation of medical protocols under the National Medical Commission Act, 2019 and the Tamil Nadu Private Clinical Establishments (Regulations) Act, 1997.</p> <p>The authorities conducted an inspection, and based on their findings, the notice was issued to the Company.</p>
Impact on financial, operation or other activities of the Company quantifiable in monetary terms to the extent possible	The above notice may result in revenue loss of Rs. ~50 Lakhs. Further, at this point of time, the Company does not foresee any material financial or operational impact of the notice.
Action taken by the Company in this Connection	The patient's spouse had requested the treating doctor, to allow him inside the operation theatre to take photo/video record of the "Happy" moments, the doctor allowed the same and educated him about the "strict aseptic conditions" and "patient privacy" have to be maintained. The doctor took this decision without informing the Hospital's Management and the incident occurred due
