The Company is in absolute compliance with the directives from the authorities and will continue to work towards a swift resolution of the matter. In compliance with the Notice, existing in-patients will be shifted to the Company's other nearby hospital to avoid any inconvenience.

The Company is in process of filing appeal before the TNCEA State Enforcement Officer / Medical & Rural Health Services Director for removal of suspension.
